AHA's Supportive Housing Programs provide at-risk populations – who are often homeless or soon-to-be homeless – with a stable housing arrangement that includes intensive case management and support services to address individual needs. At-risk populations include homeless individuals and families, people with physical, mental, or developmental disabilities, military veterans, families separated due to the lack of housing, youth aging out of foster care, and other target groups that need quality, affordable housing.

For AHA, Supportive Housing holds a meaningful place among the housing opportunities we make available to low-income families and individuals.

AHA's Supportive Housing Programs

Sponsored & Tenant-Based Supportive Housing (TBSH)	Program Description
Family Unification Program (Housing Choice FUP)	HUD program administered by public housing agencies (PHAs) in partnership with Public Child Welfare Agencies (PCWAs) where Housing Choice Vouchers (HCVs) are provided to: 1) Families for whom the lack of adequate housing is a primary factor, or 2) Youth, ages 18-21, who left foster care at age 16 or older and who lack adequate housing.
Veterans Affairs Supportive Hous (VASH)	HUD program for homeless veterans that combines a tenant-based voucher with case management and clinical services provided by the Department of Veterans Affairs (VA).

KickStart <i>Pilot</i>	Self-sufficiency program designed to assist former foster care youth. Offered in partnership with the Department of Family and Children Services (DFCS) Independent Living Program (ILP).
FLOW Pilot	Tenant-Based program in conjunction with the City of Atlanta and the Continuum of Care (CoC) for formerly chronically homeless residents of Permanent Supportive Housing (PSH) who no longer need intensive support services.

Public Housing	Through revitalization of former Harris Homes and in partnership with Integral, AHA's development partner, The Gardens at CollegeTown provides housing assistance, case management and intensive, comprehensive on-site support services to residents with mental or developmental disabilities.

Project Based Rental Assistance (PBRA)	Using PBRA to facilitate affordable housing, AHA partners with private and faith-based property owners to serve and provide on-site support and case management services for at-risk populations, to include homeless or formerly homeless families, adults, seniors, youth, and veterans, and persons with mental or developmental disabilities.
