Scope and Content

The collection consists of the records of the City Wide Advisory Council On Public Housing, INC. including minutes and photographs (1971-1992 and undated). Topics in the minutes include discussions of the Brooke Amendment, the Tenant Preservation Program (TPP), the Modernization Program, the Tactical Anti-Crime Program (TAC), Day Care funds, Title IV-A and XVI, HUD budget cuts, Model Grievance Procedure, tenant elections, and youth programs.

HISTORICAL NOTE:

The City-Wide Advisory Council on Public Housing, INC. was incorporated Oct. 17, 1973 with an initial Board of thirty-five Directors for the purpose of providing advocacy for the rights of tenants of public and leased housing; to recommend goals, policies, and priorities; and to act as a liaison between community, the city government, and Atlanta Housing for planning progress and decision making.
