The collection consists of project records, tenant association records, photographs, and artifacts of the Carver Community Homes.

HISTORICAL NOTE:

Carver Community Homes was located at 140 Meldon Avenue, SE in District 1 and was completed February 17, 1953. It held 990 units, and was on 105.2 acres of land. It was part of the Low Rent Housing Program.

Carver Community Homes was redeveloped as the Villages at Carver and as an Atlanta Housing sponsored mixed income, mixed finance community.
