## **Heman E. Perry Homes and West Highlands at Perry Boulevard records. -- 1950s-2015. -- 10.50 Cubic feet (21 boxes)**

### **Scope and Content**

The collection consists of project records, publications, and photographs of Heman Edward Perry Homes (better known as Perry Homes) and its redevelopment as West Highlands at Perry Boulevard.

#### **HISTORICAL NOTE:**

The Heman Edward Perry Homes was also known as the "Sweat Road Project." The groundbreaking for its construction took place on April 26, 1953 and it was scheduled for completion the Winter of 1954. It was part of the Low Rent Housing Program.

On March 24, 1975 a tornado touched down southwest downtown Atlanta business district including Perry Homes, destroying at least 100 of the 1,100 apartments there, injuring 36 persons, and severely damaging a small shopping center. Perry Homes sustained an estimated loss of \$2,100,000. The tornado continued to wreak havoc on an eight-mile long path of destruction in less than 15 minutes. Three people were killed and the Governor had to hide during the duration of the storm in the center of the Governor's mansion, which also sustained severe damage. Mayor Manard Jackson held a press conference to discuss the tornado damage. The press conference revealed that 125 families were displaced by the tornado. In as little as a week after the tornado, all displaced families were rehoused. AH employees also headed a depository for contributions to help the people made homeless. The AH Redevelopment Office provided clothing, food, and household goods and furniture. Other public housing tenants offered to share their homes.

The West Highlands at Perry Boulevard community was the redevelopment of the Heman E. Perry Homes.
