The collection consists of project records of Suburban Courts.

#### HISTORICAL NOTE:

Surburban Courts located at 3787 Martin Luther King Jr. Drive was built in 1969 by an independent contractor. The Atlanta Housing acquired the property under the Turnkey program. The property was originally purchased by Atlanta Housing as apart of the Leased Housing Program. In 1983, Atlanta Housing moved the management of this property to its Homebuyers Program.
