Scope and Content

The collection consists of implementation plans and annual reports as approved by Atlanta Housing's Board of Commissioners and as released in draft for public comment. It also includes protocols and related documentation, evaluations presentation materials, correspondence, and audiovisual materials.

HISTORICAL NOTE:

Moving to Work (MTW) is a demonstration program established in 1996 by Congress and administered by the U.S. Department of Housing and Urban Development (HUD), giving certain "high performing" public housing agencies the flexibility to design and test various approaches for: (a) facilitating and providing quality affordable housing opportunities in their localities, (b) facilitating opportunities for family success and self-sufficiency, and (c) achieving greater efficiency and effectiveness. Atlanta Housing received its MTW designation in 2001 and executed its MTW Agreement with HUD on September 23, 2003, the initial period of which was effective from July 1, 2003 through June 30, 2010. Atlanta Housing and HUD negotiated and executed an Amended and Restated MTW Agreement, effective as of November 13, 2008, and further amended by that certain Second Amendment to the Moving to Work Agreement, effective as of January 16, 2009.

In 2004, Atlanta Housing submitted to HUD its first Business Plan, using this new statutory and regulatory framework (herein referred to as the "Business Plan" or "CATALYST Plan"). Atlanta Housing's Business Plan and its subsequent annual MTW implementation plans, on a cumulative basis, outline Atlanta Housing's priority projects, activities and initiatives to be conducted during each fiscal year.
